## ORDINANCE NORS

AN ORDINANCE CAMMELLING THE ACCEPTENT HERETOTORY WADE AGAINST CHRYALL PROPERTY OWNED BY D. D. HACKING, OF ALBANY, OREGON.

WHEREAS, by virtue of appropriate proceedings heretofore had by the Council of the City of Albany, Gregon, D. D. Hackleman was assessed for bonefits account to Lots 1 and 2 in Flock 7 in Hackleman's Peirst Addition to the City of Albany for and on account of the construction of a lateral sewer beginning at the manhole in Oak Street Sewer where said sewer crosses Santiam Road in Albany, Oregon, and Eunning thence southeasterly on the same angle as said Santiam Road a distance of 815 feet in said City, and

WHERRAS, the aforesaid lots are situated almost wholly within the gulch and meanders of Tennywinkle freek in said fity and are of considerably less value than the amount of the assessments heretofore assessed against said lots as aforesaid, and that the improvement for which said assessments were made and levied is no benefit to said lots.

## "HEREFORK

THE PEOPLE OF THE CITY OF ALBANY DO OFDAIN AS FOLLOWS:

frection 1. That the Recorder of the City of Albany be and he is hereby directed to cancel so much of the assessment heretofore made and entered against D. D. Hackleman for benefits account to Lots One (1) and Two (2) in Block Seven (7) in Wackleman's Weirs' Wirst addition to the City of Albany, Oregon, for and on account of the construction of a lateral sewer beginning at the manhole in Oak-Street Sewer where said sewer crosses Santiam hoad in Albany, Oregon, and running thence southeasterly on the same angle as said Santiam hoad a distance of 815 feet in said City, as was properly chargeable to said property, to-wit, the sum of \$50.38.

Section 2. That the Recorder of the City of Albany be and he is hereby directed to enter in the Pocket of City Liens to the credit of the said D. D. Hacklennn, a gredit for the amount of the ascessment cancelled by Section 1 of this ordinance, to-wit: the sum of \$50.35.
