Sention As The fire limits of the City of Albany shall be bounded by a line commencing where the center line of "ater ftreet intermeets the center line of Tashington Street and running thence Southerly following the center line of Tashington Street to a point equally distant from the center lines Second Street and Third Street, thence "naterly parallel with the center line of Second Street to the center of Ferry Street at a point equally distant from Second Street and Third Street, thence foutherly along the center of Terry to the center line of Third Street, thence Easterly along the center line of "hird "treet to a point in the conter of said "hird Street 67 1/8 fect Westerly from the West line of Lyon Street; thence Southerly parallel with the West line of Lyon Atrest and 37 1/3 f st Westerly from said line to a point in the center of Winth Street which is 67 1/8 feat West from the "est line of said Tyon Ctreet; thence Sasterly along the center line of said Winth Street to a point in the center of said Winth Ctreet 67 1/3 feet Masterly from the Wast line of wold Lyon Street; thence Northerly parallel with the Mast line of Lyon Street and 67 1/8 feet therefrom to the center of Second Street, thence Fasterly following the center line of Second Street to its intersection with the center line of Baker Street, themse Northerly following the center line of Taker Street to a point equally distant from the center lines of First Street and Water Street, thouse Westerly parallel with the center line of Wirst Street to the center line of Lyon Street, thence Fortharly following the center line of 'you "treet to the Center line of inter ftreet, thomac Westerly following the center line of "ater Street to the place of beginning.

Thereas it is necessary for the immediate preservation of the public poses, health and safety of the inhabitants of the City of Albany that this ordinance shall become immediately effective, an emergency is hereby declared to exist, and this ordinance shall take effect immediately from and after its passage by the "ouncil and its approval by the "sayor.
