ORDINANCE No. 1151

A BILL FOR AN ORDINANCE concerning shade and ornamental trees or shrubs of whatsoever kind or character growing or protruding over the streets, sidewalks, alleys or other public ways in the City of Albany, Oregon, and providing a penalty for the violation thereof.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person, firm or corporation owning or occupying real property within the City of Albany, Linn County, Oregon, to permit any tree or shrub of any kind or character, ornamental or otherwise, growing in any street, alley or other public way or in the parking contiguous to said property or growing upon said property so owned or occupied to protrude or grow over any street, sidewalk, alley or other public way in the City of Albany, Linn County, Oregon, at a height less than nine feet from said street, sidewalk, alley or other public way.

Section 2. The Superintendent of streets of the City of Albany, Oregon, when he finds any of the conditions existing as described in Section 1, of this ordinance, shall immediately give the person, firm or corporation so affected written notice of said condition and said person, firm or corporation so affected shall have a period thereafter of ten days in which to eliminate said condition.

Section 3. Any person, firm or corporation violating the provisions of Section 1 of this ordinance and thereafter failing to comply with the written request of the Superintendent of Streets of the City of Albany, Oregon, shall be deemed guilty of misdemeanor and upon conviction thereof before the Recorder of the City of Albany, Oregon, shall pay a fine of not less than Two Dollars (\$2.00) nor more than One Hundred Dollars (\$100.00); and, in default of the payment thereof, shall be confined in the City Jail of the City of Albany, Oregon, at the rate of one day for each Two Dollars of said penalty.
