ORDINANCE NO 1162

An ordinance authorizing and directing the Recorder of the City of Albany, Oregon. to cancel certain street improvement assessment liens upon pajent to the City Treasurer of the City of Albany, of the sum of \$316.63, and the filing in the office of the City Recorder of the City of Albany aduplicate receipt therefor, and to repeal Ordinance No. 1074 passed by the Council June 27th, 1923, and approved by the Mayor June 28th, 1923,

That, WHEREAS, the City of Albany has heretofore duly levied an assessment upon the south half of block No. 110 in Hackleman's Addition to the City of Albany for the improvement of Second Street, and

WHRHAB, the present owner of the South-Rast Quarter of said block No. 110 desires to fully and completely satisfy the prorate assessment heretofore levied and now existing against said portion of said block, and

WHEREAS, said assessment heretofore levied against said block 110 in Hack-leman's Addition to the City of Albany, Oregon, has been duly enetered in the Bond Lien Docket of said City in volume 3, at page 83, and

the proportion of said assessment against the softheast quarter of said block No. 110 in Hackleman's Addition to said City is the sum of \$398.28, which said assessment was levied against said property in the name of Masy V. Riley, Thomas R. Riley, James V. Riley, Nellie M. Scott and J. William Riley, and

WHRHEAS, under and by virtue of Ordinance No. 1074 of the City of Albany passed by the Council June 27, 1923, and approved by the Mayor June 23, 1923, the sum of \$291.79 was collected by the City of Albany for the purpose of relieving the the west half of the southeast quarter of said block No. 110 from its prorata share of said assessment, and

WHRREAS, by said Ordinance No. 1074 an error% in the description of said portion of said block so intended to be relieved by the payment of said sum Of \$291.79 was made in describing that portion of said property as being the west half of the southwest quarter instead of the west half of the southwest quarter of said block No. 110.

THEREFORE

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The Recorder of the City of Albany, Oregon, is hereby authore ized upon the parent of the sum of \$316.63 to the City treasurer of the City of Albany, Oregon, and the filing of a duplicate receipt therefor, which said payment shall be made as and for the amount of the street assessment due the the City of Albany, to cancel and mark as satisfied the lien now existing in favor of the City of Albany on the entire southeast quarter of said block 110 in said addition to said City.

Section 2. That Ordinance No. 1674 passed by the Council June 27, 1923, and approved by the Mayor June 28th, 1923, be and the same is hereby repealed.
