

ORDINANCE NO. 1204

AN ORDINANCE declaring a surplus on account of the improvement by Guy F. Pyle, of Seventh Street, from the east curb line of Calapooia Street to the east line of Yukon Street, in the City of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:••

Section 1. That a surplus of \$1433.65 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and Guy F. Pyle, for the improvement of Seventh Street, from the east curb line of Calapooia Street to the east line of Yukon Street, in said City, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany, Oregon, is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, the sum of \$1433.65, based on the several amounts heretofore assessed and entered therein, to defray the cost of improving said Street, said surplus being in favor of the following named persons, owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:-


