

ORDINANCE No. 1269

AN ORDINANCE authorizing the construction of a pile trestle bridge on Second Street at Pennywinkle Creek in the City of Albany, Oregon, providing for the manner in which the same may be constructed and for the payment of the cost thereof.

WHEREAS, the old bridge at Pennywinkle Creek on Second Street in the City of Albany, Oregon, is in a dangerous and dilapidated condition and is unsafe and inadequate for public use and benefit, and

WHEREAS, the Mayor and Council deem it expedient and necessary and for the best interests of the City of Albany that a new pile trestle bridge be constructed at the location aforesaid for the public vehicular and passenger traffic over and along said Second Street, and

WHEREAS, the Mayor and Council have ascertained and do hereby ascertain, declare and determine that said bridge may be constructed at less cost to said City of Albany by constructing the same on said City's own account rather than by letting contract for same;

THEREFORE THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Council of the City of Albany be and it is hereby authorized and directed to construct a pile trestle bridge on Second Street at Pennywinkle Creek, in said City of Albany; that said bridge be constructed under the supervision of Charles H. Leonard, engineer, and in accordance with such plans and specifications therefor as may be determined by the Council's committee on streets and public property.

Section 2. That the Council of the City of Albany by and through Charles H. Leonard, engineer, shall have power and authority to purchase and hold utensils, machinery and material, and to hire or rent the same, and to hire and discharge servants and laborers and to do any and all things necessary in the construction of said bridge as a contractor might do. Said engineer shall keep an accurate account of all expenses, fully itemized, in constructing said bridge, and shall report the same to the Council from time to time during the progress of the work, and upon the approval thereof and the order of the Council the Recorder is hereby authorized and directed to draw warrants against the general funds of said City in payment of the cost of the construction of said bridge.
