

**ORDINANCE No. 1316**

AN ORDINANCE authorizing the Mayor and Council of the City of Albany, Oregon, to purchase certain real property from Lena Sternberg for Municipal Air-Port and/or airplane landing field purposes; appropriating the sum of Two Hundred Fifty Dollars (\$250.00) of the funds derived from the sale of the bonds of the City of Albany authorized by Chapter XI of the charter of said City in payment thereof and authorizing the Recorder to draw a warrant on said funds payable to the said Lena Sternberg in the sum of Two Hundred Fifty Dollars (\$250.00) in payment of said purchase price:

THE PEOPLE OF THE CITY OF ALBANY, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. The Mayor and Council of the City of Albany, Oregon, are hereby authorized and directed to purchase of Lena Sternberg the following described real property to be used as a municipal Airport and/or airplane landing field, to-wit:

Beginning at the northeast corner of the Anderson Cox D.L.C., Notification No. 696, claim No. 49 in Tp. 11 S.R. 3 West of Wil-lamette Meridian, thence north 1°39' West 5:00 chains to the east-erly boundary line of the Pacific Highway, thence southerly along said easterly line of said Pacific Highway to the north line of said claim No. 49; thence north 88°45' East 6:00 chains to the place of beginning, containing one and one-half acres, more or less, in Linn County, Oregon.

Section 2. That there be and is hereby appropriated from the funds de-rived from the sale of the bonds of said City authorized by Chapter XI of the Charter of the City of Albany the sum of Two Hundred Fifty Dollars (\$250.00) in payment of the purchase price of the real property described in Section 1. hereof, and the Recorder is hereby authorized and directed to draw a warrant on said fund payable to the said Lena Sternberg in the sum of Two Hundred Fifty Dollars (\$250.00) and to deliver the same to her upon her delivery to the City of Albany a good and sufficient deed conveying said described premises to said City of Albany, accompanied by an abstract of title thereto, showing her to be possessed of a fee simple title thereto free of in-cumbrances.
