

ORDINANCE No. 1369

An ordinance levying a tax for the City of Albany, Oregon, upon the current assessment made upon taxable property of said City for the year 1932, for taxes to be due and payable in the year 1933, and to separately appropriate for each officer, department, building, institution, streets, highways, sewers, parks and other purposes, the amount of the taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Council of the City of Albany, Oregon, does hereby make, determine, declare, and levy the amount of taxes in and for said City based upon the current assessment made upon the taxable property therein for the year 1932, said taxes to become due and payable in the year 1933, in sume as follows, to-wit:
