

## ORDINANCE NO. 1462

AN ORDINANCE awarding the contract for furnishing and supplying the labor, equipment and materials and the construction of a municipal building, including swimming pool filter facilities therein and construction of extensions and improvements to the street lighting system of the City of Albany, and authorizing the Mayor and Recorder to make and execute a contract with T.Y. McClellan, for furnishing said labor, equipment and materials and declaring an emergency.

WHEREAS, bids have been received by the Mayor and Council of the City of Albany, Oregon, for furnishing and supplying the labor, equipment and materials for the construction of a municipal building containing swimming pool filter facilities therein and the construction of extensions and improvements to the street lighting system of said City and said bids have been duly opened, read and compared and it appears that T.Y. McClellan is the lowest bidder for said labor, equipment and materials, said bid being in the sum of \$18,494.50, alternates A,B,C and F having been deducted; and

WHEREAS, such bid is within the available funds of the City of Albany for said project and said bid is in due and regular form and that said bid is duly certified;

THEREFORE THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Contract for furnishing and supplying the labor, equipment and materials in the construction of a municipal building, including swimming pool filter facilities therein, and the construction of extensions and improvements to the street lighting system of the City of Albany in accordance with the plans and specifications therefor heretofore approved and now on file in the office of the City Recorder of said City be and the same is hereby awarded to T.Y. McClellan for the sum of Eighteen Thousand Four hundred Ninety Four and 50/100 (\$18,494.50) Dollars, alternates A,B,C and F having been deducted.

Section 2. The Mayor and Recorder of said City of Albany be and they are hereby authorized to make and execute a contract in quadruplicate and any other documents, agreements or instruments in connection therefor for and on behalf of said City of Albany and with said T.Y. McClellan for furnishing the labor, equipment and materials aforesaid, subject however to the approval of the Federal Emergency Administration of Public Works.

Section 3. Whereas, the peace, health and safety of the people of the City of Albany require that this ordinance shall become immediately effective, therefore an emergency is hereby declared to exist and this ordinance shall be and become in full force and effect immediately upon its final passage by the Council and approval by the Mayor.
