

A BILL FOR:

AN ORDINANCE declaring a surplus on account of the construction of lateral sewers as follows:

HACKLEMAN STREET LATERAL 12 - Beginning at the manhole 18 feet west of the southwest corner of Lot 23, Block 3, Oak Grove Acres and running westerly along the South line of Lots 1, 2, & 3, Block 2, Oak Grove Acres 177 ft., also beginning at the Northeast corner of Lot 4, Block 2, Oak Grove Acres, and running Southerly through the center of Block 348 ft., also, beginning at the manhole 18 ft. West of the Southwest corner of Lot 17, Block 3, Oak Grove Acres and running Westerly 116.7 ft. to manhole, thence Southerly 592 ft. to the Southwest corner of Lot 21, Block 2, Oak Grove, and branching at this point 39.5 ft. to the East and 33.5 ft. to the West along lot lines.

HACKLEMAN STREET LATERAL 13 - Beginning at manhole 16 ft. West of N.W. corner of Lot 22, Block 3, Oak Grove Acres, and running thence Southerly 16 ft. from the W. line of Bl. 3 446.6 ft. to manhole, thence Easterly along N. Line of Lot 16, Block 3, 89.0 ft., thence Southerly 306.5 ft. to the Northeast corner of Lot 11, and continuing Southerly along center line of Block to S.W. corner of Lot 7 at manhole, and branching 109 ft. from manhole to N.W. cor. of Lot 5, and also 96 ft. from same manhole to N.E. cor. of Lot 3.

in the City of Albany, Linn County, Oregon, by Leonard & Slate Oreg. Ltd., and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral sewers, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$901.77 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and Leonard & Slate Oregon Ltd. for the construction of lateral sewers as follows:

HACKLEMAN STREET LATERAL 12 - Beginning at the manhole 18 feet west of the southwest corner of Lot 23, Block 3, Oak Grove Acres and running westerly along the South line of Lots 1, 2, & 3, Block 2, Oak Grove Acres 177 ft., also beginning at the Northeast corner of Lot 4, Block 2, Oak Grove Acres, and running Southerly through the center of Block 348 ft., also, beginning at the manhole 18 ft. West of the Southwest corner of Lot 17, Block 3, Oak Grove Acres and running Westerly 116.7 ft. to manhole, thence Southerly 592 ft. to the Southwest corner of Lot 21, Block 2, Oak Grove, and branching at this point 39.5 ft. to the East and 33.5 ft. to the West along Lot lines.

HACKLEMAN STREET LATERAL 13 - Beginning at manhole 16 ft. West of N.W. corner of Lot 22, Block 3, Oak Grove Acres, and running thence Southerly 16 ft. from the W. line of Block 3 446.6 ft. to manhole, thence easterly along N. Line of Lot 16, Block 3, 89.0 ft., thence Southerly 306.5 ft. to the Northeast corner of Lot 11, and continuing Southerly along center line of Block to S.W. corner of Lot 7 at manhole, and branching 109 ft. from manhole to N.W. corner of Lot 5, and also 96 ft. from same manhole to N.E. corner of Lot 3.

in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column thereof, in the sum of \$901.77 based upon the several amounts heretofore assessed for constructing such lateral sewers, said surplus in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
