

ORDINANCE NO. 1875

A BILL FOR:

AN ORDINANCE declaring a surplus on account of the improvement of FIRST STREET from the east line of Geary Street to the S.P.R.R. right of way at Columbus Street; SECOND STREET from the east line of Geary Street to the west line of Cleveland Street; FOURTH STREET from the east line of Geary Street to the west line of Chicago Street; FIFTH STREET from the east line of Geary Street to the west line of Burkhardt Street; SIXTH STREET from the east line of Geary Street to the west line of Burkhardt Street; SEVENTH STREET from the east line of Geary Street to the west property line of the Oregon State Highway property; CHICAGO STREET from the south line of First Street to the south line of St. James Addition; BURKHART STREET from the south line of Front Street to the north line of the Santiam Road; and COLUMBUS STREET from the south line of Front Street to the S.P.R.R. right of way; in the City of Albany, Linn County, Oregon, by D. F. McKenzie and O. L. Bowman, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the making of said improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$2386.48 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie and O. L. Bowman for the improvement of First Street from the east line of Geary Street to the S.P.R.R. right of way at Columbus Street; Second Street from the east line of Geary Street to the west line of Cleveland Street; Fourth Street from the east line of Geary Street to the west line of Chicago Street; Fifth Street from the east line of Geary Street to the west line of Burkhardt Street; Sixth Street from the east line of Geary Street to the west line of Burkhardt Street; Seventh Street from the east line of Geary Street to the west property line of the Oregon State Highway property; CHICAGO ST. from the south line of First Street to the south line of St. James Addition; Burkhardt Street from the south line of Front Street to the north line of the Santiam Road, and Columbus Street from the south line of Front Street to the S.P.R.R. right of way, in the City of Albany, Oregon and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column thereof, in the sum of \$2386.48 based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement of said Street, said surplus in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
