ORDINANCE # 1967

AN ORDINANCE DECLARING A SURPLUS AND A DEFICIT ON ACCOUNT OF THE IMPROVEMENT OF TWELFTH STREET FROM THE WEST LINE OF ELM TO THE EAST LINE OF COTTAGE, IN THE CITY OF ALBANY, LINN COUNTY, OREGON BY KEESLER CONSTRUCTION CO., AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED ON THE RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THE IR PROPORTIONATE SHARE OF SUCH SURPLUS OR DEFICIT.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1,378.16 and a difficit of \$316.69 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon and Keebler Construction Co. for the improvement of Twelfth Street from the west line of Elm to the East line of Cottage in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of maid improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens for said City, in the surplus column and deficit column thereof, in the sum of \$1,378.16 and \$316.69 respectively, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement, of said street, said surplus and deficit parcels of real estate, and in the sums as follows to-wit:
