

ORDINANCE NO. 2450

AN ORDINANCE VACATING A PORTION OF LINN STREET AND A PORTION OF WILLAMETTE STREET FROM THE WEST LINE OF EVERGREEN STREET A DISTANCE OF 354.98 FEET MORE OR LESS

WHEREAS, the Council of the City of Albany did, by resolution number 251 at the Council Meeting on the 10th day of September, 1952, set the hour as 7:00 o'clock p.m. on October 8, 1952, as the time for hearing of objections to the proposed vacation of a portion of Linn Street and a portion of Willamette Street as more particularly described in the said resolution and did in the said resolution direct the City Recorder to publish and post notice of said proposed vacation as required by law, and

WHEREAS, notice has been posted and published as required by law and in the said resolution the people of the City of Albany do ordain as follows, and

WHEREAS, the said hearing, on the eighth day of October, 1952, was duly held and no remonstrance having been filed with the City Recorder and no persons appearing objecting to the proposed vacation

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a portion of Linn Avenue and a portion of Willamette Avenue, more particularly described as follows, to-wit:

1. Beginning at a point on the North line of Block 26, in Burkhart Park Addition to the City of Albany, Linn County, Oregon, said point being 529.98 feet West of the East line of the Leander Burkhart Donation Land Claim No. 50, in T. 11 S., R. 3 W. of W.M., in Linn County, Oregon, running thence Easterly along the North boundary line of Block 26 to the Northeast corner of said Block 26; thence Northerly to the Southeast corner of Block 27 in said Addition; thence Westerly, along the South line of said Block 27, to a point which is 529.98 feet West of the East line of said Claim No. 50; thence Southerly to the point of beginning.

11. Beginning at a point on the North line of Block 25, in Burkhart Park Addition to the City of Albany, Linn County, Oregon, said point being 529.98 feet West of the East line of the Leander Burkhart Donation Land Claim No. 50, in T. 11 S., R. 3 W. of W.M., in Linn County, Oregon, running thence Easterly along the North boundary line of Block 25 to the Northeast corner of said Block 25; thence Northerly to the Southeast corner of Block 26 in said Addition; thence Westerly, along the South line of said Block 26, to a point which is 529.98 feet West of the East line of said Claim No. 50; thence Southerly to the point of beginning.

be and the same is hereby vacated as a public street in the City of Albany.
