AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY THE SOUTH RESIDENTIAL STORM SEWER TRUNK AND LATERAL IMPROVEMENTS.

Recitals:

1. The South Residential Storm Sewer Districts, as referred to in this ordinance and previous resolutions and ordinances, are those areas outlined on the accompanying map marked Exhibit A.
2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvements are set forth in Resolutions 399 and 407 and in Ordinance No. 2723.
3. The assessments set forth in the following ordinance are based upon the report and recommendation of the City Engineer in compliance with Ordinance No. 2723.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The total cost of the sewer improvements in the South Residential Storm Sewer Trunk and Lateral Districts is hereby determined to be \$158,526.23. The following represents a breakdown of the trunk and lateral costs to be assessed against the property particularly benefited thereby:

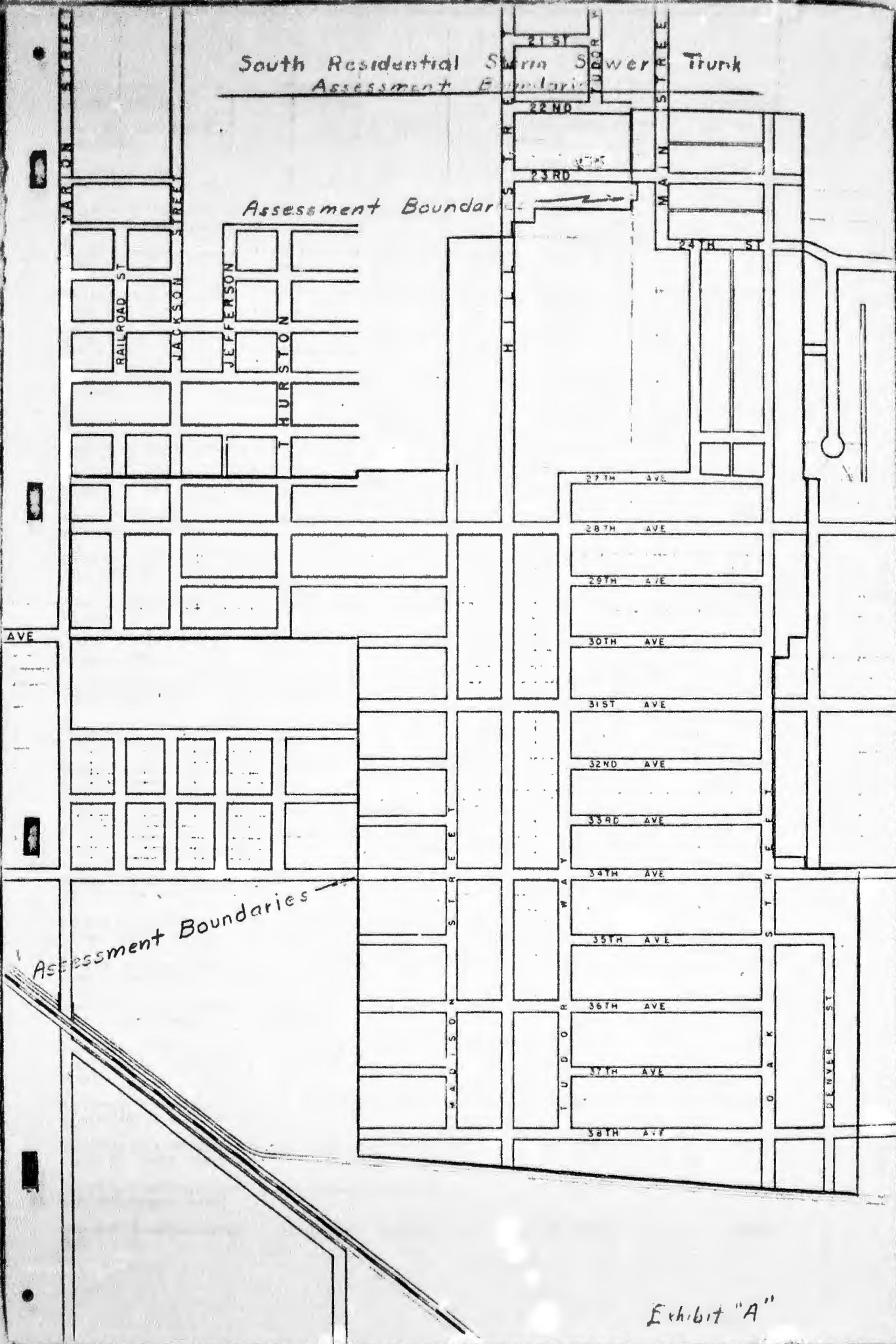

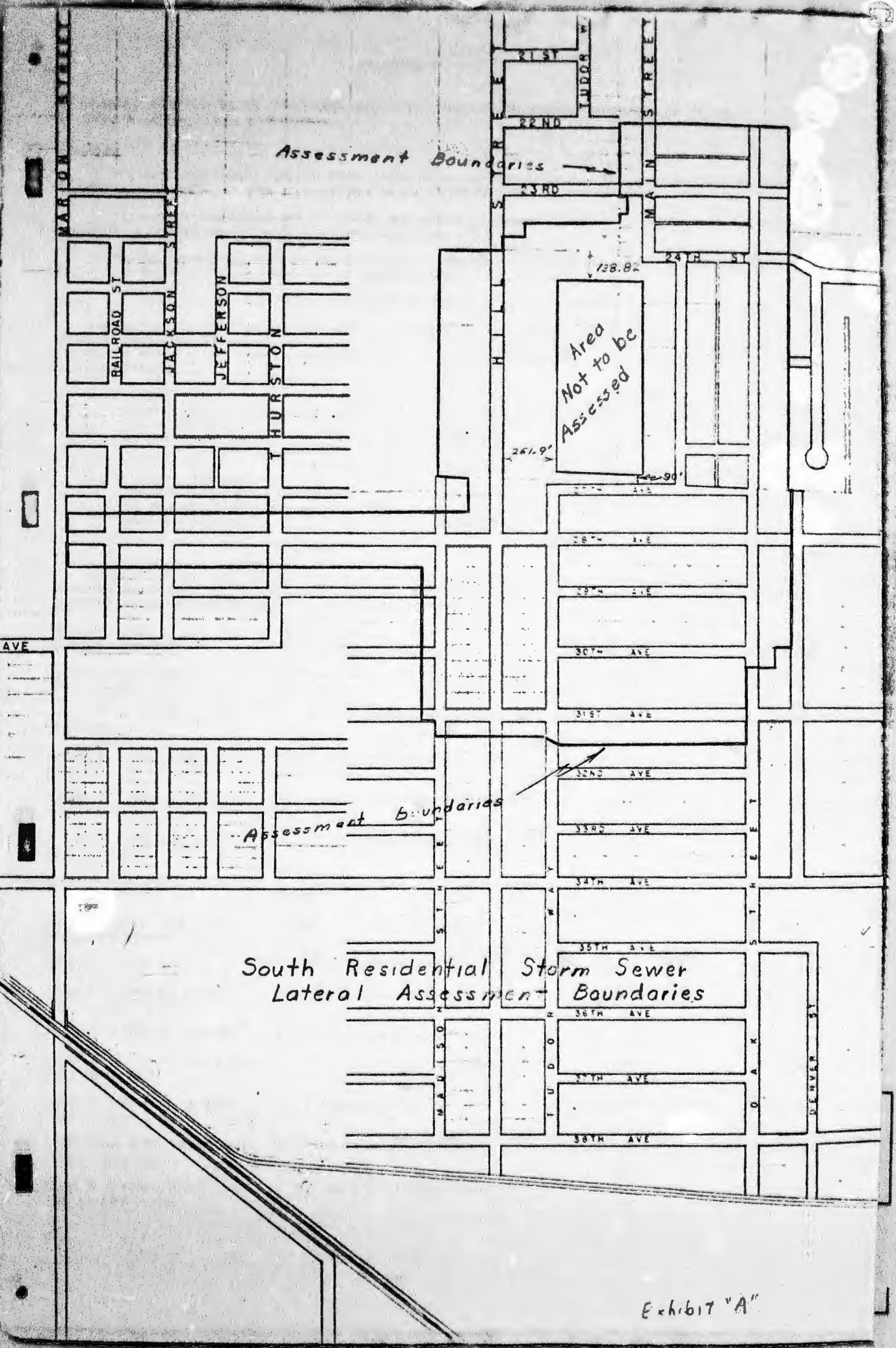
