

TITLE: AN ORDINANCE AUTHORIZING THE ISSUANCE OF A CITATION IN LIEU OF CONTINUING CUSTODY OF THE PERSON WHO IS ARRESTED FOR A MINOR CRIME OR OFFENSE, ESTABLISHING THE FORM OF CITATION TO BE USED AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: CITATION

For violation of minor offenses, a police officer or a private citizen is authorized to issue a citation to appear in court as an alternative to arrest and detention.

Section 2: FORM OF CITATION

A form of citation to appear in court shall be as follows:

Section 3: EMERGENCY CLAUSE


WHEREAS, the peace, health and safety of the people of
