

ORDINANCE NO. 3870

TITLE: AN ORDINANCE AMENDING ORDINANCE NO. 3681, Section 9, AND ORDINANCE NO. 3794, Section 8A ESTABLISHING RESIDENTIAL AND COMMERCIAL RATES TO BE CHARGED BY CONTRACTOR FOR THE COLLECTION OF REFUSE IN THE CITY OF ALBANY, OREGON.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: AMENDMENT

That Ordinance No. 3681 is amended in Section 9 to read as follows:

"Section 9: The residential rates to be charged by a contractor for the collection of refuse in the city shall not exceed those established by the following schedule:

A 32 gallon (or less) can collected once weekly	\$3.00/mth.
Second can	1.74/mth.
Each additional can	1.74/mth.

The contractor shall charge business enterprises (excluding apartment houses), a reasonable fee, the same to be agreed upon according to a fair consideration of the amount and nature of the garbage and material to be disposed of in each individual instance. (Apartment houses shall be charged on the basis of the residential schedule).

The charge for occasional additional pickup of refuse removed from yards or buildings shall be a reasonable charge for each pickup and such additional charge as the size and nature of the particular articles to be hauled will justify.

Section 2: AMENDMENT

Section 8a: COLLECTION RATE FOR COMMERCIAL CONTAINERS.

The Commercial and industrial rate to be charged by all contractors for the collection of garbage and rubbish shall not exceed those established by the following rate schedule:

INDUSTRIAL - RATES FOR DROP BOXES:

- 20 Yard Drop Box - \$36.00 per load
- \$144.00 minimum per month for regular use
- 1.00 demurrage for each day after 3 days temporary

30 Yard Drop Box - \$54.00 per load
\$216.00 minimum per month for regular use
1.00 demurrage for each day after 3 days temporary

Section 3: That inasmuch as it is deemed necessary for the public health, peace and safety of the citizens of the City of Albany, that the provisions shall be immediately operative, it is hereby declared that an emergency exists and this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.
