ORDINANCE NO. 4435

AN ORDINANCE TO LEVY AN ASSESSMENT AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY A SEWER CONNECTION AT 2706 27TH AVENUE SE, 2623 25TH AVENUE SE, 2717 28TH AVENUE SE, 2308 WAVERLY DRIVE SE, AND AT 2714 WAVERLY DRIVE SE AND DECLARING AN EMERGENCY.
