ORDINANCE NO. 4567

AN ORDINANCE calling a special election to submit to the voters the question of contracting a general obligation bonded indebtedness in the amount of \$6,000,000 to finance construction of sewer and storm drain separation facilities and declaring an emergency.

WHEREAS, the City Council of the City of Albany, Oregon, has determined that there is a need to construct a sewer and storm drain separation facilities; and

WHEREAS, the costs of construction is estimated to be \$6,000,000 for the construction of sewer and storm drain separation facilities; now, therefore,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

- (1) A special election is hereby called for the purpose of submitting to the qualified voters of the City the question of contracting a general obligation bonded indebtedness in the sum of \$6,000,000 to finance construction of sewer and storm drain separation facilities.
- (2) The special election hereby called shall be held on the 29th day of March, 1983.
- (3) Not less than 34 days prior to the election the City shall cause to be delivered to the County Clerk of Linn County the attached Notice of Measure Election, which by this reference is incorporated herein.
- (4) The City Recorder shall cause a notice of election to be posted in a conspicuous place in the City Hall and to be published in the Democrat Herald not less than 10 days prior to the election. The notice shall be in substantially the form of the attached Notice of Measure Election.
- (5) Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health, and safety of the citizens of the city of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon its passage by the Council.
