## ORDINANCE NO. 4934

AN ORDINANCE TO LEVY AN ASSESSMENT AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY A WATER CONNECTION AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: The water connection as referred to in this ordinance is to provide a water connection to serve the structure located on the property described as follows:

<u>Section 2</u>: The water connection and the assessment for the same shall be levied according to the provisions of Albany Municipal Code Section 11.01.100.

Section 3: The total cost of the water connection is as follows:

<u>Section 4</u>: The City Recorder is hereby directed to enter a statement of the assessment as above provided in the docket of the city liens and give notice thereof as provided by law.

<u>Section 5</u>: Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health and safety of the city of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon passage by the Council and approval by the Mayor.
