ORDINANCE NO. 5103

AN ORDINANCE DECLARING STREET NAME CHANGES IN FIRST ADDITION TO TIMBER LINN SUBDIVISION FOR THE STREET NAMES LISTED BELOW AND DECLARING AN EMERGENCY (FILE NO. SR-07-93).

WHEREAS, a property owner requested the street name changes following the process identified in Section 12.640 of the Revised Albany Development Code.

WHEREAS, staff determined that the street name changes were appropriate: and

WHEREAS, notices of the tenative staff decision were mailed to affected property owners on September 1, 1993 as required by Section 12.630(3a) of the revised Albany Development Code; and

WHEREAS, no requests were received by the Planning Division of the City of Albany for a Public Hearing on the proposed street name changes; and

WHEREAS, the tenative decision became final on October 11, 1993; and

WHEREAS, the Albany City Council on February 9, 1994, voted to approve the proposed Street Names Changes shown on the attached Exhibit 'A' at the request of Allen B. Pynn; and

NOW, THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: Glendale Street SE is hereby changed to Hummingbird Street SE

Section 2: Jaycee Court is hereby changed to Kingfisher Court SE

Section 3: Timber Court is hereby changed to Meadowlark Court SE

Section 4: First Avenue is hereby changed to Azalea Avenue SE

Section 5: Second Avenue is hereby changed to Dogwood Avenue SE

<u>Section 6</u>: EMERGENCY CLAUSE. Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health, and safety of the citizens of this city of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon its passage by the Council.
