Said charges are for the purpose of persons desiring to connect a private sanitary sewer line to a city sanitary sewer line from property against which no assessment has been levied, Ordinance No. 5164. On November 3, 1999, Building Permit #B-0755-99 was issued, authorizing connection to the existing sanitary sewer.


