ORDINANCE 5443

AN ORDINANCE AMENDING ORDINANCE NO. 5041, SEGREGATING THE SEWER ASSESSMENT ON PROPERTY OWNED BY DONALD AND PENNI DURST AND DESCRIBED AS TAX LOT NO. 602, OF PARCEL 10S-04W-36BC; AND DECLARING AN EMERGENCY.

WHEREAS, Map 10S-04W-36BC, Tax Lot 600 was assessed a sewer assessment by the North Albany Sanitary Sewer project, SS-9007, on April 14, 1993, by Ordinance No. 5041. In 1995, a lot-line adjustment was requested (LA-01-95) and the Benton County Assessor reassigned the Tax Lot as 602. The assessment was levied as described below.


