

RESOLUTION NO. 560

BE IT RESOLVED that the Recorder has heretofore prepared a list of liens, in tabular form, that are now delinquent, said list containing the docketed lien, whether bonded or unbonded, the name of the person assessed, a particular description of the property, the amount of the lien or amount of installment due, and other facts necessary, it is hereby declared that the below described unbonded liens are more than sixty (60) days past due and the bonded liens are delinquent more than one year.

IT IS FURTHER RESOLVED that the whole sums are owing and both principal and interest are due and payable at once.

BE IT FURTHER RESOLVED that the Recorder proceed with collection of the said liens as set forth in 223.505 to 223.650 ORS.
