


RESOLUTION NO. 703

BE IT RESOLVED by the Council of the City of Albany, Oregon, that there shall be initiated such proceedings as are necessary to vacate a portion of Lansing Avenue between Bain and Cox Streets which is more particularly described as follows, to-wit:

Beginning at 5/8" iron rod on the East line of and S. 1°39'E. 89.95 feet from the Northeast corner of Lot 11, Block 10, of said Freeway Addition; and running thence S. 1°39'E. 35.00 feet; thence on a 30.0 foot radius curve to the right (the long chord of which bears S.43°24'W. 42.46 feet) a distance of 47.18 feet; thence S.88°27'W 253.08 feet; thence on a 1650.0 foot radius curve to the right (the long chord of which bears N.87°53.7'W. 210.38 feet) a distance of 210.51 feet; thence N.84°14.4'W. 253.27 feet; thence on a 573.0 foot radius curve to the right (the long chord of which bears N. 77°27.7'W 135.26 feet) a distance of 135.58 feet; thence N. 70°41'W. 75.71 feet; thence on a 30.0 foot radius curve to the right (the long chord of which bears N.25°36'W. 42.49 feet) a distance of 47.21 feet to a point on the west line of and S.19°29'W. 100.38 feet from the Northwest corner of Lot 20 in said Block 10; thence N. 19°29'E. 14.84 feet to a 5/8" iron rod; thence on a 30.0 foot radius curve to the left (the long chord of which bears S. 31°45'E. 46.78 feet) a distance of 53.65 feet to a 5/8" iron rod; thence S.82°59'E. 450.32 feet to the Southwest corner of Lot 15 in said Block 10; thence on a 1407.78 foot radius curve to the left (the long chord of which bears S. 88°16'E. 210.29 feet) a distance of 210.48 feet to the Southwest corner of Lot 13 in said Block 10; thence N. 88°27'E. 249.85 feet to a 5/8" iron rod; thence on a 30.0 foot radius curve to the left (the long chord of which bears N.43°24'E. 42.46 feet) a distance of 47.18 feet to the place of beginning.

The Recorder of the City of Albany is hereby directed to give notice of a public hearing on the proposed said vacation of street as above described to be held in the Council Chambers at the City Hall on the 25th day of July, 1962, at the hour of 7:15 o'clock p.m. P.S.T., by publication of notice thereof once a week for four consecutive weeks in a newspaper of general circulation within the City of Albany and by posting notice thereof at each end of the proposed vacation and at two places within the area vacated within five days of first publication date. Said notice to set forth the time, place and purpose of said hearing and to contain a description of streets proposed to be vacated.
