## GAS PIPELINE EASEMENT

THIS EASEMENT, granted this <u>10</u> day of <u>0C to ber</u> 2007 by the **City of Albany**, a Municipal Corporation, herein called "Grantor," to **NORTHWEST NATURAL GAS COMPANY**, herein called "Grantee."

#### WITNESSETH:

The Grantor has this day bargained and sold and by these presents does bargain, sell, convey, and transfer unto the Grantee, easement and right-of-way, including the right to enter upon the real property hereinafter described, and to install, operate, maintain, repair, replace, and change the size of a gas pipeline or pipelines and related equipment.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A 10-foot wide easement across Bryant Park, more particularly described in attached EXHIBIT "A" and shown in attached EXHIBIT "B."

- 2. The easement described herein grants to the grantee, the right to enter and use the above described property to do or to take any of the actions described in this document.
- 3. Grantee will install the pipeline with the least amount of disturbance to Grantor's property as possible and will, to the extent practical, restore Grantor's property to the condition existing prior to Grantee's construction. Grantee will reimburse Grantor for any damage to Grantor's property caused by Grantee during use of the easement.
- 4. Grantor agrees that no buildings or other structures or potentially large growing trees will be placed upon the easement and that no actions will be allowed that would jeopardize or interfere with the safe operation of the pipeline.
- 5. The easement granted is in consideration of \$6,500.00, receipt of which is acknowledged by the Grantor.




# Exhibit "A"


