A RESOLUTION AUTHORIZING THE FINANCE DIRECTOR TO SIGN A CONTRACT BETWEEN THE CITY OF ALBANY AND CARSON FOR COMMERICAL CARD-LOCK FUEL FOR FIVE YEARS BEGINNING JULY 1, 2017

WHEREAS, the City of Albany requested proposals through a formal competitive Request for Proposal (RFP) process; and

WHEREAS, the City advertised in the *Albany Democrat-Herald* and the *Daily Journal of Commerce* on May 1, 2017, and received two competitive proposals from Carson and PetroCard; and

WHEREAS, PetroCard has served the City over the past five years and their contract ends June 30, 2017; and

WHEREAS, the proposals were significantly different in their Cost Proposals and Carson was found to be economically better and the cost for unleaded fuel is much lower in price, resulting in significant cost savings to the departments that use unleaded fuel; and

WHEREAS, the City desires to enter into a contract with Carson for approximately five years commencing July 1, 2017, with an option to extend the contract up to two additional one-year terms.

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council hereby accepts the cost proposal submitted by Carson for commercial card-lock fuel (Exhibit A) for five years beginning July 1, 2017; and

BE IT FURTHER RESOLVED that the Finance Director is hereby authorized to sign a contract between the City of Albany and Carson, beginning July 1, 2017.
