A RESOLUTION ACCEPTING THE COST PROPOSAL AND AWARDING A CONTRACT TO PETROCARD, AND AUTHORIZING THE FINANCE DIRECTOR TO SIGN A CONTRACT BETWEEN THE CITY OF ALBANY AND PETROCARD FOR COMMERICAL CARD-LOCK FUEL FOR FIVE YEARS BEGINNING IN OCTOBER 2017, AND REPEALING RESOLUTION NO. 6621.

WHEREAS, the City of Albany requested proposals through a formal competitive Request for Proposal (RFP) process in May 2017 and received competitive proposals from Carson and PetroCard; and

WHEREAS, Carson proposed a lower Cost Proposal providing significant cost savings to the City; and

WHEREAS, Council accepted the Cost Proposal and awarded a contract to Carson on June 28, 2017, by Resolution No. 6621; and

WHEREAS, Carson's Cost Proposal was in error and would be rejected by the City in accordance with ORS 279B.100; and

WHEREAS, the City desires to enter into a contract with PetroCard to provide citywide commercial card-lock fuel for five years commencing in October 2017, with an option to extend the contract up to two additional one-year terms;

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council hereby accepts the Cost Proposal submitted by PetroCard and awards a contract to PetroCard to provide commercial card-lock fuel (Exhibit A) for five years beginning in October 2017; and

BE IT FURTHER RESOLVED that the Finance Director is hereby authorized to sign a contract between the City of Albany and PetroCard, beginning in October 2017; and

BE IT FURTHER RESOLVED that Resolution No. 6621 is hereby repealed.
