
Legal Description for Right-of-Way Dedication

A 4 00-foot wide right-of-way dedication lying over the eastern 4.00-feet of tax lot 11S03W17BB04100, in the NW 1/4 of Section 17, T11 South, R3 West, Willamette Meridian, City of Albany, Linn County, Oregon, more particularly described as follows;

Beginning at a point at the southeast corner of the property described in Linn County Deed Records, Volume 1658 Page 176, said point being at the intersection of the west right-of-way line of Geary Street and the north right-of-way line of 24th Avenue and henceforth known as the POINT OF BEGINNING; thence N 1°36'00" W 111 75 feet along said west right-of-way line of Geary Street to the north property line of said property; thence S 89°05'00" W 4.00 feet along said north property line; thence S 1°36'00" E 111 75 feet to the northern right-of-way line of 24th Avenue; thence N 89°05'00" E 4 00 feet along the northern right-of-way line of 24th Avenue to the POINT OF BEGINNING. EXHIBIT B RIGHT-OF-WAY DEDICATION ORA AND BRIDGET A SHEFFLER






