A RESOLUTION OF THE ALBANY CITY COUNCIL, ACTING AS THE LOCAL CONTRACT REVIEW BOARD, WAIVING COMPETITIVE BIDDING, ESTABLISHING A CLASS SPECIAL PROCUREMENT, AND AWARDING A SPECIAL PROCUREMENT CONTRACT WITH FKC CO., LTD. FOR FKC SCREW PRESSES

WHEREAS, Albany Municipal Code 2.66.060(11), Oregon Revised Statute (ORS) 279B.085, and Oregon Administrative Rule (OAR) 137-047-0285 allow the city council, acting as the local contract review board, to authorize the use of the special procurement process for the selection of goods and services for a special purpose; and

WHEREAS, such authorization must be based on written findings submitted by the department seeking the exception that describe the selected special procurement method to be used and the circumstances that support the use of the special procurement as set forth below; and

WHEREAS, there are two belt filter presses located inside the biosolids building that provide dewatering at the Albany-Millersburg Water Reclamation Facility (WRF); and

WHEREAS, new dewatering equipment is required to replace the existing belt filter presses, which are at the end of their service life; and

WHEREAS, public works has determined that FKC screw presses provide the desired performance at a size that can fit within the existing biosolids building; and

WHEREAS, FKC Co., Ltd., is a sole-source supplier of FKC screw presses, so awarding a contract to FKC Co., Ltd., is unlikely to encourage favoritism in the awarding of a public contract or to substantially diminish competition for public contracts; and

WHEREAS, the use of a class special procurement to purchase FKC screw presses from FKC Co., Ltd., provides a solution that is not available from any other vendor; and

WHEREAS, the use of a class special procurement process to purchase FKC screw presses will substantially promote the public interest in a manner that could not be practicably be realized by complying with requirements that are under ORS 279B.055, 279B.060, 279B.065, or 279B.070 or under any rules adopted thereunder.

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council, acting as the local contract review board:

SECTION 1. Adopts the following findings:


- 1. The City requires a class special procurement to procure FKC screw presses for dewatering at the Albany-Millersburg WRF.
- 2. The public works department has researched dewatering options and found that FKC Co., Ltd., is the sole supplier of FKC screw presses.
- 3. FKC screw presses meet the design and performance requirements for dewatering at the Albany-Millersburg WRF without the need for additional equipment.

SECTION 2. Notwithstanding the provisions of Municipal Code Section 2.66.060, the public works department is authorized and directed to use the class special procurement method to procure dewatering equipment.

SECTION 3. The public works director is hereby directed to negotiate and award a class special procurement contract for FKC screw presses to FKC Co., Ltd., after the City has given public notice for seven days of its intent to award a contract, per OAR 137-047-0285 and ORS 279B.085.
