A RESOLUTION ADOPTING PRIVATE PROPERTY IMPOUND TOWING RATES AND REPEALING RESOLUTION NO. 6569

WHEREAS, Albany Municipal Code (AMC) Chapter 13.90.130 allows the city council to set maximum towing rates by resolution; and

WHEREAS, the council adopted Resolution No.6569 on February 8, 2017, setting private property impound rates; and


WHEREAS, employer costs continue to rise, and Albany towing companies have requested that the allowed rates be adjusted; and

WHEREAS, it is important to set rates that allow businesses to continue providing this needed service.



NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that the private property impound towing rates set forth in Exhibit A are hereby adopted; and

### Exhibit A

The terms used if not defined under the Albany Municipal Code may be found under the Oregon Revised Statutes or Oregon Administrative Rules.

**Basic Fees for Towing may not exceed**

Class A Hookup Fee	\$165
Class B Hookup Fee	\$198
Class C Hookup Fee	\$300

The following fees may be added, as appropriate if documented on a receipt

<b>Towed Mileage up to a maximum of 7 miles (mileage measured to the 1/10<sup>th</sup> of a mile):</b>	
Class A	<del>\$74.00</del>
Class B	<del>\$74.50</del>
Class C	<del>\$85.00</del>
<b>Labor/Standby Time on Scene in excess of 30 minutes</b>	<del>\$2518/</del>
When charging a tower must report the time of arrival at and the departure from the scene.	quarter hour
<b>After Hours Release Fee</b> (applicable only after 6 pm or before 8 am Monday-Friday, all day Saturday and Sunday and National Holidays)	\$25
<b>Release at Scene (RAS) This fee may only be assessed if:</b> <ol style="list-style-type: none"> <li>1. The tower has completed the hookup and attachment of all safety equipment and the tow truck's transmission is engaged and it has commended driving forward.</li> <li>2. If all above requirements have not been met and vehicle owner/driver returns, an RAS fee shall not be charged.</li> </ol>

Class C	\$300
<b>Storage Fees</b> (after 4 hour grace period, starting from time of notice to Albany Police Department)

<b>Lien Filing Fee</b>	
Value under \$1,000	<del>\$12550</del>
