

## **CITY OF ALBANY, OREGON INVITATION TO BID (ITB)**

## Water Treatment Facility Wetwell and Sedimentation Basin Cleanout Bids Due by 2:00 p.m. (Pacific Time), Tuesday, October 10, 2023

Notice is hereby given that the City of Albany (City), Oregon, is requesting bids from Contractors to provide the City of Albany with annual preventative maintenance to clean the City of Albany wet wells (vertical entry wells and ramp entry basins) at water treatment facilities over a two-year term, beginning December 1, 2023, with the option to extend two additional one-year terms.

Optional Pre-bid Site Visits will be held on Wednesday, September 20, 2023, 10:00 a.m. for a tour of all facilities, starting at Albany Millersburg Water Treatment Plant (WTP), 33883 Berry Drive, Albany, then to the Vine Street WTP, 300 Vine Street, Albany. Contractors are encouraged to attend to ensure site clearance is adequate for Contractor's trucks. All attendees must confirm their intent to attend by contacting Chris Germond at chris.germond@cityofalbany.net.

Prospective bidders are solely responsible for checking the website to determine if addenda or clarifications have been issued. Bid responses must be submitted to Diane Murzynski, in the Finance Department, at procurement@cityofalbany.net, not later than 2:00 p.m. (Pacific Time), Tuesday, October 10, 2023. Submittals will be considered time-stamped and received by the City when received in the procurement email inbox. The email subject line should include the project name "Water Treatment Facility Wetwell and Sedimentation Basin Cleanout".
