

Ord 603

An Ordinance authorizing the Mayor and Recorder of the City of Albany, Oregon, to enter into a contract with the Warren Construction Company for the improvement of Water Street, from the east curb line of Lafayette Street to a point 78 feet east of the east line of Sherman Street.

The People of the City of Albany Do Ordain as follows:

Whereas, by Ordinance No. 597 of the City of Albany, Oregon, it was ordered that the following street in said City of Albany, Oregon, to-wit: Water Street, from the east curb line of Lafayette Street to a point 78 feet east of the east line of Sherman Street, be improved in the following manners to-wit:

- First: By grading said street to the proper sub-grade.
- Second: By paving the roadway of said street full width with full intersections with gravel bitthulithic pavement.
- Third: By laying and constructing gravel bitthulithic curbs.
- Fourth: By constructing catch basins.
- Fifth: By constructing inlets.
- Sixth: By laying vitrified sewer pipe.

Said improvement to be made in accordance with the charter and ordinances of the City of Albany, Oregon, and the plans and specifications and estimates of the City Engineer then on file with the City Recorder of said City of Albany; and,

Whereas, it was provided in said Ordinance that the Recorder of said city give notice for bids for the making of said improvement in the manner provided by law and by said ordinance; and,

Whereas, after due notice and advertisement for the bids made and given by the City Recorder of said City, according to law and the ordinance last aforesaid, to-wit: On the 27th day of July, 1913, the Warren Construction Company, a corporation, of Portland, Oregon, presented to the Council of said City its bid for making said improvement, which bid was made in due form, and in conformity with all the conditions imposed by law and the Council, by which said bid, said Warren Construction Company proposed to furnish all material and implements and perform the labor necessary to make the above described improvement for the following named prices:

Excavation, per cubic yard,	\$2.75
Fill, per cubic yard,	\$0.25
Gravel Bitthulithic Pavement, per square yard,	\$1.00

Travel Bituminous Headers, per lineal foot,	\$ 2.37
Catch basins, each,	\$ _____
Inlets, type A, each,	\$ 15.00
Inlets, type B, each	\$ 8.00
Six inch vitrified sewer pipe, per lineal foot,	\$ 1.05

And Whose said Warren Construction Company was the lowest bidder on said proposed work and said bid was the lowest and best therefor.

Section 1. That the said bid of the Warren Construction Company for said improvement of said described street be and the same is hereby accepted, and the Mayor and Recorder of said City are hereby authorized to enter into a contract in writing with the said Warren Construction Company, for the making of said improvement as aforesaid, on behalf of the City of Albany, Oregon, upon the terms mentioned in said bid, and the agreement herein above mentioned.

Said contract to provide further, that the work of said improvement shall commence within thirty days after the signing of said contract, and be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before the 1st day of November, 1912, and the City of Albany, Oregon, shall be deemed to suffer damages to the extent of \$25.00 per day for each and every day the work is delayed beyond said specified time; and that the Warren Construction Company furnish a bond in the sum of \$5,000.00 to be approved by the Mayor of the City of Albany, Oregon, having as sureties some Surety Company authorized to do business in the State of Oregon, conditioned on the faithful performance of said contract, on the part of the Warren Construction Company, and further indemnifying the City of Albany against any claims or liens for labor, work or materials on the part of any person arising out of such contract.
