

Ordinance
No. 615-

An ordinance requiring the Oregon and California Railroad Company to place its trackage on Water Street through and over the whole length thereof upon the established grade and requiring good, safe and sufficient crossings to be made across said railroad track.

Whereas, the Council of the City of Albany passed Ordinance No. 147 on October 26, 1886, which ordinance was approved by the Mayor October 30, 1886 and it grants a right of way for a railroad track over and along Water Street in said City for the full length thereof; and,

Whereas said ordinance expressly reserves the right to prescribe the manner of such use at any and all times when the council of said City might consider the public welfare of said city requires it so to do; and,

Whereas in opinion of the council of the City of Albany the public welfare of the city demands that the said Water Street shall be brought up to and placed upon the established grade of said street

The People of the City of Albany Do Ordain as Follows:

Section 1. That the Oregon and California Railroad Company, its successors or assigns of the franchise or right granted by Ordinance No. 147 of the City of Albany, passed by the council October 26, 1886, and approved October 30, 1886 to which it is hereby required on or before the first day of December, 1912 to place all of its trackage along Water Street in the City of Albany, Oregon, the entire length of said street upon the established grade and to properly construct good and safe crossings at each intersection of said Water Street by other streets by grading such crossing to the proper subgrade, the full width of each and every crossing and grading the same full width of each and every crossing six inches deep with wash gravel. That said work shall be begun on or before the first day of October, 1912 and completed in a good and workmanlike manner on or before the first day of December, 1912.

Section 2. Whereas existing conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety, an emergency exists and this ordinance shall take effect and be in full force from and after its approval by the Mayor.
