

An Ordinance declaring a surplus on account of the construction of a lateral sewer by W. C. Weaver beginning at the main sewer in Baker Street and running westerly through the center of Block Four, Eastern Addition to the City of Albany, across Spruce Street, and through the center of Block 17 in the City of Albany, Oregon, and directing the Recorder of the City of Albany, to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Hooket & City Liens in the City of Albany, Oregon, for making such improvements, their proportionate share of such surplus.

The People of the City of Albany do Ordain as follows:

Section 1. That a surplus of 3.668 per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and W. C. Weaver for the construction of lateral sewer beginning at the main sewer in Baker Street and running westerly through the center of Block Four, Eastern Addition to the City of Albany, across Spruce Street, and through the center of Block 17 in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Hooket of City Liens in the surplus column thereon a credit of 3.668 per cent, based upon the several accounts heretofore assessed and entered therein to defray the cost of the improvement of said lateral sewer; said surplus being in favor of the following named persons, owners or reputed owners of such various parcels of real estate and in sums as follows, to-wit:
