

ORDINANCE No. 1088

AN ORDINANCE CANCELLING THE ASSESSMENT HERETOFORE MADE AGAINST CERTAIN PROPERTY OWNED BY D. D. HACKLEMAN, OF ALBANY, OREGON.

WHEREAS, by virtue of appropriate proceedings heretofore had by the Council of the City of Albany, Oregon, D. D. Hackleman was assessed for benefits accruing to Lots 1 and 2 in Block 7, in Hackleman's Heirs' First Addition to the City of Albany for and on account of the construction of a lateral sewer beginning at the manhole in Oak Street Sewer where said sewer crosses Santiam Road in Albany, Oregon, and running thence southeasterly on the same angle as said Santiam Road a distance of 815 feet in said City, and

WHEREAS, the aforesaid lots are situated almost wholly within the gulch and meanders of Pennywinkle Creek in said City and are of considerably less value than the amount of the assessments heretofore assessed against said lots as aforesaid, and that the improvement for which said assessments were made and levied is no benefit to said lots,

WHEREFORE

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Recorder of the City of Albany be and he is hereby directed to cancel so much of the assessment heretofore made and entered against D. D. Hackleman for benefits accruing to Lots One (1) and Two (2) in Block Seven (7) in Hackleman's Heirs' First Addition to the City of Albany, Oregon, for and on account of the construction of a lateral sewer beginning at the manhole in Oak Street Sewer where said sewer crosses Santiam Road in Albany, Oregon, and running thence southeasterly on the same angle as said Santiam Road a distance of 815 feet in said City, as was properly chargeable to said property, to-wit: the sum of \$50.38.

Section 2. That the Recorder of the City of Albany be and he is hereby directed to enter in the Docket of City Liens to the credit of the said D. D. Hackleman, a credit for the amount of the assessment cancelled by Section 1 of this ordinance, to-wit: the sum of \$50.38.
