ORDINANCE NO. 940

AN ORDINANCE CREATING A SOARD OF PARK COMMISSION AS PROVIDING FOR APPOINTMENT, FILLING OF VACANCIES, AND THE ORGANIZATION AND POWERS OF SAID COMMISSION.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. A Board of Park Commissioners consisting of five

Section 2. The Mayor, with the approval of the Council, shall appoint said Board of Park Commissioners each of which said Commissioners shall be a resident of the City of Albany. Said Commissioners shall serve for a term of three years, except that the terms of the Commissioners of the Board first appointed shall expire in one, two and three years, and the Mayor in his appointment shall designate the length of term to be served by each Commissioner and the remainder of the calendar year of 1919 shall constitute the first year of each member's term. All vacanties shall be filled by appointment in the same manner, and, if in an unexpired term, for the residue of the term only. The Mayor may, by and with the consent of the Council, remove any Commissioner for misconduct or neglect of duty. No compensation shall be paid or allowed any Commissioner.

Section 3. Said Commissioners shall, immediately after their appointment, meet and organize by the election of one of their number president. and by the election of such other officers as they may deem necessary. They shall take such rules and regulations for their own guidance and for the government of the park properties of the City of Albany committed to their care as may be expedient, not inconsistent with the charter of the City of Albany.

Section 4. Said Board of Park Commissioners shall have exclusive control of the expenditure of all moneys appropriated by the Council or received from other sources for the improvement, care and maintenance of, and also exclusive control of the supervision and management of all parks and public grounds of the City of Albany, except such as may by the terms of any grant or conveyance be connicted to some other board, but said Board shall not have authority to incur any obligations for or on behalf of the City of Albany without first having obtained the approval of the Council of said City of Albany.

Section 5. On or before the thirty-first day of December of each year, the said Board of Park Commissioners shall make a report in writing to the Council, stating the condition of all property under its management, the various sums of money received from all sources, the amount and purposes of expenditures, and such other information and recommendations as it deems of general interest.
