ORDINANCE NO. 1038

A BILL FOR AN ORDINANCE Granting unto Holman & Jackson a copartnership, the right and privilege to operate upon the streets of the City of Albany the truck described herein, and to earry on the business of delivering merchandise within the City of Albany, Oregon:

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. That there is hereby granted unto Holman & Jackson, a copartnership, the right and privilege to operate along and upon the streets, alleys and other public thoroughfares in the city of Albany, Oregon, the following described motor truck, to-wit:

1 Ford 4-cylinder delivery truck; Oregon license, 1922, No. 57523.

and to conduct a delivery service from their place of business to their various patrons with the City of Albany, and said described truck and no other is to be used in conducting said delivery service under this franchise, unless the Council shall upon application by said grantee permit a substitution or addition to said equipment.

Section II. That the said grantee shall maintain an office and place of business, and telephone, to be used in connection with said business and for the convenience of the public and the patrons of the said grantee.

Section III. That the said grantee shall in consideration of the privilege herein granted pay the City of Altany the sum of \$16.00 which said sum may be divided into three equal parts and be paid in advance.

Section IV. That if the said grantee shall fail or refuse to make any such payment of the amounts herein reserved to the City of Albany, when the same becomes due and payable, or shall be twice convicted of violation of the laws of the State of oregon or the ordinances of the City of Albany, relating to motor vehicles, such railure or convictions shall be deemed sufficient cause for the revocation of this franchise, and the right of revocation for such causes is hereby reserved by the City of Albany.

Section V. That the privilege herein granted shall inure to and may be exercised by the said grantee for a period commencing on Farch 22nd. 1922, and ending on January 1st. 1923, unless the same shall be sooner revoked for the causes herein contained.
