

A BILL FOR AN ORDINANCE To ascertain and determine the probable cost of constructing a lateral sewer which the Council of the City of Albany, Oregon, has determined by Resolution No. 32 adopted by the Council on the 12 day of Sept., 1923, beginning at a point at the West end of the lateral sewer in Block 90 in Monteith's Southern Addition to the City of Albany, Oregon, and extending Westerly through the middle of Block No. 89 of said Addition a distance of 350 feet to a point which is Easterly 50 feet distant from the West boundary line of said Block No. 89 in the City of Albany, Oregon; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement that is assessed upon each lot or part thereof adjacent to said improvement; to direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens as provided by the charter of said City.

WHEREAS, On the 22 day of August, 1923 the Council of the City of Albany, Oregon, duly adopted a resolution requiring the Engineer C. H. Leonard of said City to make plans and specifications for the improvement of Block 89 in Monteith's Southern Addition to the City of Albany, Oregon, from a point beginning at the West end of the lateral sewer in Block 90 in Monteith's Southern Addition to the City of Albany, Oregon, and extending Westerly through the middle of Block No. 89 of said Addition a distance of 350 feet to a point which is Easterly 50 feet distant from the West boundary line of said Block No. 89 in the following manner to-wit:

1. By laying 334 lineal feet of 8 inch straight sewer.
2. By excavating and refilling
3. By installing "Y" branches
4. By installing lamp holes
5. By installing man hole

and for estimates of the work to be done in the construction of the above described lateral sewer and the probable cost thereof and requiring that such plans, specifications, estimates and probable cost be filed in the Recorder's Office of said City, said resolution being endorsed "Resolution No. 31" and adopted on the 22 day of August, 1923 and

WHEREAS, The Engineer C. H. Leonard of the City of Albany pursuant to said Resolution No. 31 made plans, specifications and estimates as directed by said resolution for the above described improvement in the manner specified in said resolution No. 31 and filed said plans, specifications and estimates in the Recorder's Office in said City on the 12th. day of September, 1923 and

WHEREAS, The said Council on the 12th. day of September, 1923, by Resolution No. 32 duly adopted by said Council, determined and resolved that it deemed it expedient and that said Council proposed to construct the above described lateral sewer; and

WHEREAS, In and by said Resolution No. 32 adopted as aforesaid by the Council the Recorder of said City was duly ordered and directed by said

Council to Give notice of said proposed sewer improvement as provided by the charter of said City of Albany, and

WHEREAS, The Recorder in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said proposed sewer improvement in the manner provided by the charter of said City of Albany, and

WHEREAS, The said Council in and by said Resolution No. 32 ascertained and determined the total probable cost of making said improvement to be paid by the owners of the real property adjacent to said improvement as specified in said Resolution No. 32 to be the sum of \$367.84.

T H E R E F O R E

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That an Eight inch (8") lateral sewer shall be laid beginning at a point at the West end of the lateral sewer in Block No. 90 in Monteith's Southern Addition to the City of Albany, Oregon, and extending Westerly through the middle of Block No. 89 of said Addition a distance of 350 feet to a point which is Easterly 50 feet distant from the West boundary line of said Block No. 89, in the City of Albany, Oregon, in the following manner, to-wit:

1. By laying 334 lineal feet of 8 inch straight sewer
2. By excavating and refilling
3. By installing "Y" branches
4. By installing lamp holes
5. By installing man hole

All in accordance with said Resolution No. 31 and the plans and specifications for said improvement filed by the engineer with the Recorder of said City of Albany on the 12 day of September, 1923.

Section 2. That the probable cost of making said improvement in the manner heretofore determined by the Council of said City of Albany, Oregon, in and by said Resolution No. 32, by laying 334 lineal feet of 8 inch lateral sewer pipe, by excavating and refilling, by installing "Y" branches, by installing lamp holes, by installing man hole, to be paid by the owners of the real property adjacent to said improvement and especially and particularly benefited thereby is the sum of Three Hundred Sixty-seven and Eighty-four hundredths Dollars (\$367.84).

Section 3. That the proportionate share of said probable cost of said improvement assessed upon each lot or part thereof adjacent to said improvement as aforesaid and as determined by said Council in and by said Resolution No. 32, is hereby ascertained and declared to be the sum set and placed immediately after the separate description of each of such lots or parts thereof as follows, to-wit:
