A BILL FOR AN ORDINANCE Declaring a surplus on account of the improvement by U. G. Hayne, beginning at a point at the West end of the lateral sewer in Block 90, in Monteith's Southern addition to the City of albany, Oregon and extending Westerly through the middle of Block No. 89 of said Addition a distance of 350 feet to a point which is Easterly 50 feet distant from the West boundary line of said Block No. 89 in the City of albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:
