

**ORDINANCE NO. 1148**

A BILL FOR AN ORDINANCE Declaring a surplus on account of the improvement by Guy F. Pyle on Ferry Street from the North curb line of Twelfth Street to the North line of Thirteenth Street in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofre assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of Three Hundred Eighty-seven and 27/100 Dollars (\$387.27) is hereby ascertained, determined and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and Guy F. Pyle for the improvement of Ferry Street from the North curb line of Twelfth Street to the North line of Thirteenth Street in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof, a credit in favor of the following named persons, owners, or reputed owners of such parcels of real estate and in the sums as follows, to-wit:


