ORDINANCE No. 1308

AN ORDINANCE providing for the licensing of skating rinks within the City of Albany, Oregon, repealing all ordinances and parts of ordinances in conflict herewith, providing a penalty for violation hereof, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person, firm or corporation to operate a skating rink within the City of Albany, Oregon, without first having obtained a license from the recorder of said City, so to do, and no such licensee shall be permitted to operate any skating rink in said City except at the place, for the time, and within the limitations provided by such license and the charter and ordinances of said City of Albany.

Section 2. All licenses for the operation of skating rinks shall specify the time for which said license shall be effective, a description with reasonable certainty of the place, room or building where said skating rink may be operated, the fee paid for such license, the days of the week and the hours of the day during which said skating rink may be operated, and shall be issued and subscribed by the Recorder of the City of Albany with the seal of said city attached.

Section 3. The license fee for the operation of skating rinks within the City of Albany, Oregon, shall be \$30.00 for a license period of 6 months, payable in advance, provided that all licenses issued during the first half of any year shall expire on June 30th of that year, and all licenses issued subsequent to June 30th of any year shall expire December 31st of that year, and provided further that the minimum charge for any license issued under this ordinance shall be the sum of \$30.00.

Section 4. Any person violating any of the provisions of this ordinance upon conviction thereof before the Recorder's Court of said City of Albany shall be punished by fine of not more than \$100.00, or by imprisonment in the City Jail for a period of not more than 50 days, or by both such fine and imprisonment at the discretion of the Court.

Section 5. The Council of the City of Albany, after having given at least one day's written notice, and having served the same upon any such licensee, may by resolution in regular or special meeting, suspend or revoke any license granted under the provisions of this ordinance for any cause or causes at its discretion.

Section 6. That in order to protect the health, life and property and to preserve and enforce the good government, order and security of the City of Albany, and its inhabitants, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council and approval by the Mayor.


