ORDINANCE NO. 1816

AN ORDINANCE to establish and define the fire limits of the city of Albany, Oregon, and to repeal all ordinances and parts of ordinances in conflict herewith.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS: --

Section 1. The fire limits of the City of Albany, Oregon, shall be bounded by a line commencing at a point where the center line of Washington Street intersects the south bank of the Willamette River, and running thence southerly, following the center line of Washington Street to the center line of the alley between Second and Third Streets; thence easterly along the center line of said alley to the center line of Farry Street; thence southerly along the center line of Ferry Street; thence southerly along the center line of Third Street; thence easterly along the center line of Third Street to a point 67.8 feet westerly from the west line of Lyon Street; thence southerly parallel with the west line of Lyon Street to a point in the center line of Fourth Street; thence easterly along the center line of Fourth Street; thence easterly along the center line of Fourth Street. of Fourth Street to a point 67.8 feet easterly from the east line of Lyon Street; thence northerly and parallel with the east line of Lyon Street to a point 50 feet south of the south line of Second Street; thence easterly and parallel with the south line of Second Street to the center line of Baker Street; thence with the south line of Second Street to the center line of Paker Street; thence northerly along the center line of Baker Street to the center line of Second Street; thence easterly along the center line of Second Street to center of Montgomery Street; thence northerly along the center line of Montgomery Street to a point equally distant between the north line of First Street and the south line of Water Street; Thence westerly to the center line of Lyon Street; thence northerly following the center line of Lyon Street to the south bank of the Willameter River; thence westerly along the south bank of the Willamette River and following the meanderings thereof to the slave of hericaline, provided however that lowing the meanderings thereof to the place of beginning; provided however that the Council of the City of Albany may, at its discretion, issue special building permits in such cases as to it may seem proper within the area lying north of Water Street in the above described limits.

All ordinances and parts of ordinances in conflict herewith. Bection 2. are hereby repealed.
