

ORDINANCE No. 1230

AN ORDINANCE carrying a surplus on account of the construction by U.G. Hayne of a lateral sewer beginning at the manhole in Oak Street trunk sewer and running thence easterly through block 3 and a part of block 6, in Hackleman's Heirs' First Addition to the City of Albany, Oregon, a distance of 374 feet, and directing the recorder to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$16.95 is hereby ascertained and declared to exist upon the completion of the contract entered into by the City of Albany, Oregon, and U.G. Hayne, for the construction of a lateral sewer beginning at the manhole in Oak Street trunk sewer, and running thence easterly through block 3 and a part of block 6 in Hackleman's Heirs' First Addition to the City of Albany, Oregon, a distance of 374 feet, and in favor of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany, Oregon, is hereby directed to enter in the Docket of City Liens of the City of Albany, Oregon, in the surplus column thereof, the sum of \$16.95, based upon the several amounts heretofore assessed for making such improvement, and entered therein, to defray the cost of the construction of said lateral sewer, said surplus being in favor of the various owners or reputed owners of the various parcels of real estate and in the various sums, to-wit:


