

ORDINANCE No. 1286

AN ORDINANCE declaring a deficit upon the final completion of the improvement of Second Street from the east line of Sherman Street to the west line of Oak Street in the City of Albany, Oregon, and directing the Recorder of said City to enter a statement of such deficit in the docket of City Liens.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby ascertained, determined and declared to be a deficit upon the final completion of the contract heretofore entered into with Claud Davis for the improvement of Second Street from the east line of Sherman Street to the west line of Oak Street in the City of Albany, Oregon, in the sum of \$40.77.

Section 2. That the said sum of \$40.77 is hereby declared to be an additional lien to cover said deficit and is hereby assessed upon and against the real property, lots and parts thereof, as follows, to-wit:
