A BILL FOR:

AN ORDINANCE declaring a deficit on account of the construction of lateral severs as follows: HACKLIAN STRUCT LATERAL 11 along center line of a drive in Block 1, Oak Grove Acres, 250 feet and also beginning at the manhole in the Hackleman Street Main and running thence northerly along the west line of Lots 3, 2, and 1 in Oak Grove Acres 224.3 feet, in the City of Albany, Linn County, Oregon, by Leonard & Slate Oregon Ltd., and directing the Recorder of said City to place to the debit of the several owners of the various parcels of real estate improved as heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the making of said improvement, their proportionate share of such deficit.

THE PEOPLE OF THE CITY OF ALBANY DC ORDAIN AS FOLLOWS:

Section 1. That a deficit of \$189.82 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon and Leonard & Slate Cregon Ltd. for the construction of lateral sewers as follows: Hackleman Street Lateral 11: Along center line of a drive in Block 1, Oak Grove Acres, 230 feet and also beginning at the manhole in the Hackleman Street Lain and running thence northerly along the west line of lots 3, 2, and 1 in Oak Grove Acres 224.3 feet, in the City of Albany, Oregon, against the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the construction of said sewers.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the deficit column thereof, the sur of \$189.82 based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the construction of said sewers, said deficit against the various owners, or reputed owners, of the various parcels of real estate and in the sums as follows, to-wit:
