

ORDINANCE NO. 1887

A BILL FOR:

AN ORDINANCE declaring a surplus of \$575.63 and a deficit in the amount of \$293.04 on account of the improving of Columbus Street from the south line of Pacific Highway to the north line of the Santiam Road and that portion of Bradley Street adjacent to Columbus Street lying between the Santiam Road and Pacific Highway in the City of Albany, Oregon.

The changes as represented are these deficits and surpluses and arise from the fact that there have been some changes in ownership and the amount of work to be done as compared with the engineer's original estimate.

In the city of Albany, Linn County, Oregon, by D. F. McKenzie and O.L. Bowman, and directing the Recorder of said city to place the surplus to the credit of and the deficit to the debit of the various parcels of real estate improved by this street improvement heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for said street improvement, their proportionate share of such surplus or deficit.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$575.63 and a deficit of \$293.04 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie and O. L. Bowman, for the improvement of Columbus and Bradley Streets as follows:

COLUMBUS AND BRADLEY STREET IMPROVEMENT PROJECT: - Improving Columbus Street from the south line of Pacific Highway to the north line of the Santiam Road and that portion of Bradley Street adjacent to Columbus Street lying between the Santiam Road and Pacific Highway in the City of Albany, Oregon, and the surplus is in favor of, and the deficit to be charged to, the several owners of the various parcels of real estate improved by the street improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column and the deficit column respectively, the sums of \$575.63 and \$293.04 based upon the several amounts heretofore assessed for improvement of Columbus and Bradley Streets, said surplus in favor of the various owners, and deficit to be charged to the various owners, or reputed owners in the various parcels of real estate and in the sums as follows, to-wit:
