

ORDINANCE NO. 2699

AN ORDINANCE PROVIDING FOR THE TIME AND MANNER OF IMPROVEMENT OF CERTAIN STREETS WITHIN THE CITY OF ALBANY, PROVIDING HOW THE COST OF SUCH IMPROVEMENTS SHALL BE PAID, THE PENALTY OR DAMAGE TO THE CITY BY THE PERSON OR PERSONS MAKING SUCH IMPROVEMENTS IF THE SAME SHALL NOT BE COMPLETED UPON THE TIME AGREED UPON, AND THE GIVING OF A GOOD AND SUFFICIENT BOND FOR THE FAITHFUL PERFORMANCE OF THE WORK OF SUCH IMPROVEMENTS AND PROVIDING FOR THE GIVING BY THE RECORDER OF THE CITY OF ALBANY, A NOTICE FOR BIDS FOR THE COMPLETION OF SAID IMPROVEMENTS, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1., That: The following streets to-wit:

16th Place from the East line of Thurston Street to the West line of Lafayette St., be improved in the following manner, to-wit:

Asphaltic Concrete Paving and,
Leveling course.

11th Avenue from the East line of vacated Liberty Street, to the centerline of vacated Liberty St., be improved in the following manner:

Asphaltic Concrete Paving,
Levelling course,
Base Course,
Curb and gutter,
Grading, and,
Drainage

15th Avenue from the existing pavement of Broadway to the East line of Hop Street, be improved in the following manner:

Asphaltic Concrete Paving,
Levelling course,
Base course,
Curb and gutter,
Grading, and,
Drainage

Vine Street from the existing pavement to the North line of 14th Avenue, be improved in the following manner:

Asphaltic Concrete Paving
Levelling course
Base course
Curb and gutter
Sidewalks
Drainage

20th Avenue from the existing pavement of South Elm Street to the West line of South Walnut Street, be improved in the following manner:

Levelling course
Base course
Grading, and
Drainage

Walnut Street from the North line of 19th Avenue to the North line of West 21st Ave., be improved in the following manner:

Levelling course
Base course
Grading, and
Drainage

17th Avenue from the East line of Gale St. to the East line of Lincoln Street, be improved in the following manner:

Levelling course
Base course
Grading, and
Drainage

16th Avenue from the West line of Lincoln to the existing pavement of Broadway, be improved in the following manner:

Levelling course
Base course
Grading, and
drainage

Lincoln Street from the North of 17th Avenue to
the existing pavement of Queen Avenue, be im-
proved in the following manner:

Levelling course
Base course
Grading, and
Drainage

The said improvements shall be made in accordance with the charter and ordinances of the City of Albany and the plans, specifications and estimates for the improvements of said streets, filed with the recorder on August 22, 1956, and referred to in Resolution No. 387.

The cost of making said improvements shall be paid out of the funds to be collected and arising out of the assessments hereafter to be made, ascertained and declared by the Council for the City of Albany on the lots and parts of lots adjacent to said portion of said streets so to be improved and especially benefitted thereby and from the funds budgetted by the city for said improvements.

Section 2: If the person, firm or corporation entering into a contract with the City of Albany to make said improvements shall not complete the same within the time mentioned and specified in such contract, the City of Albany shall be deemed to suffer damages on account thereof in the amount of \$25.00 per day for each and every day the completion of said work is delayed beyond the time stated in such contract, which amount shall be paid by such contractor doing the work at the completion thereof, unless the time of the completion of said improvement be extended by the Council.

Section 3: The Recorder of the City of Albany is hereby ordered and directed to immediately give proper notice for bids for the making of said improvements by publishing such notice 10 days in the Albany Democrat Herald, a newspaper of general circulation published in the City of Albany, fully describing in said notice the time and manner of doing said work of improvement of said portion of said streets.

Section 4: Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the citizens of the City of Albany, Oregon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the council and its approval by the Mayor of the City of Albany.
