

ORDINANCE NO. 2766

AN ORDINANCE TO AMEND ORDINANCE NO. 2761 A PORTION OF SECTION 2 AND SECTION 4 THEREOF AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That portion of Section 2 of Ordinance 2761 which reads as follows:
