AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY THE FIR OAKS SANITARY SEWER.

RECITALS:

- 1. The sewer assessment as referred to in this ordinance and previous resolutions and ordinances is "Fir Oaks Sanitary Sewer."
- 2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvement are set forth in Resolution Nos. 740, 747, 749, 749-A and in Ordinance No. 2864.
- 3. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance No. 2864.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: COST

The total cost of the sewer construction for the Fir Oaks Sanitary Sewer is hereby determined to be \$13,510.63. The following tabulation represents a breakdown of the costs to be assessed against the property particularly benefited thereby:

The Cost of the Fir Oaks Sanitary Sewer is to be assessed against twenty-nine properties containing a total of 357,269.6 square feet on the basis of \$0.03862805 per square foot.

NOTE: Tract 38, Fir Oaks Revised Addition has also been included in the assessment district for this project. However, in view of the fact that the tract is located one lot distant from the sewer line, it is proposed to allow \$2.00 per ft. for the width of the lot, or a total reduction \$290.00 from the assessment, to compensate for the additional 4-inch connection that must be made.

Unit cost for lateral assessment: $\frac{$13,800.63}{357269.6 \text{ s.f.}} = $0.03862805 \text{ per sq. ft.}$
