

ORDINANCE NO. 3317

AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER THE PROVISIONS OF SECTION 222.110, 222.120 AND 222.170 ORS, REGARDING THE ANNEXATION OF AREA EAST OF COLUMBUS STREET AND ADJACENT TO THE ALBANY-LEBANON CANAL ON THE NORTH, CONTIGUOUS TO THE CITY OF ALBANY, SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHEREAS, 100 percent of the owners of the property which is the subject matter of this annexation have petitioned and requested the City of Albany to annex the area hereinafter described to the City and the same being contiguous and in all respects qualifying under present statutes for annexation, and

WHEREAS, it is in the best interest of the City of Albany that a public hearing be held at the earliest possible date to consider objections to the annexation of the property herein described,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

All that portion of the following described tracts lying E. of Columbus Street:

Tract I: Beg at the SE cor of the DLC of C. D. Burkhart, Claim 52, T 11 S, R 3 W of the WM; the E along the S li of the DLC of John Burkhart and wife, 35.84 chs; th N 0°40' E 8.41 chs; th W 36.14 chs to the E li of sd claim 52; th S 2°08' E 8.36 chs to the pob, SUBJECT to the rights of the public in roads, EXCEPTING that portion lying in the Albany and Lebanon Canal.

Tract II: Beg at the SE cor of Lot 7 in the Town of Rural Dale, Rng th Wly along the S li of sd Rural Dale 24.833 chs; th Nly pll with the E li of sd Lot 7, 8.053 chs to the S li of Lot 2 in sd Rural Dale; th Ely along the S li of Lots 2, 3, 4, 5 and 6 in sd Rural Dale to the S E cor of Lot 6 in sd Rural Dale; th S along the E li of sd Lot 7, 8.053 chs to the pob. EXCEPTING therefrom the N 20 ft., being that portion of the premises N of the c/l of the vacated street Rural Dale.

Section 2: HEARING


That there shall be a public hearing as to the advisability of annexing the property described in Section 1 to the City of Albany, on the 8th day of November, 1967 at 7:15 P.M. o'clock, and the City Recorder is hereby directed to give notice of said public hearing by publishing in a newspaper of general circulation, published in the said City once a week for two (2) successive and consecutive weeks and by posting in four (4) public places a notice setting forth the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and, should the same be annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
